PAA Advocacy Report: December 2014

Advocacy Update: IRA Charitable Rollover



PAA and other charitable giving advocates have been urging Congress this year to reinstate the <u>IRA</u> <u>Charitable Rollover</u>. This important incentive allows individual donors age 70½ and older to make tax-free monetary gifts directly from their Individual Retirement Account (IRA) to charitable organizations.

Rollover Reinstated for 2014

On December 3, the House passed H.R. 5771, the Tax Increase Prevention Act of 2014, which retroactively renews the rollover and other charitable giving incentives through the end of 2014. The Senate passed the same legislation on Dec. 16, and the bill now awaits the President's signature. This provision has not yet been made permanent, though: last week, the House voted on the Supporting America's Charities Act (H.R. 5806) which would make the IRA rollover permanent, along with two other tax incentives. This bill did not succeed.

Late in the evening on December 13, the Senate passed the FY15 spending bill for the federal government. The House passed it earlier that week. The President has signed this \$1.1 trillion spending bill into law. Dubbed the "CRomnibus," the bill funds most of the government through FY15 and only the Dept. of Homeland Security through February.

What's in it for the arts:

- Level funding for the NEA at \$146.021 million
- \$25 million for arts education programs at the Department of Education
- Arts in Education remains a stand-alone program; it will not be combined into a funding pool with other academic disciplines.

NEA and NPS Collaborate Via Art Works

This collaboration comes as NPS prepares to celebrate its centennial in 2016. The agencies encourage projects that connect, engage, and introduce communities to their national parks; examples can be found on the grant guidelines page as well as in the guidelines for each artistic discipline.

The NEA's <u>funding guidelines for 2015</u> are now available online. The first application deadline is February 19, 2015.
